### Notes:

1. For St John's PCC to recover tax on your donations, you must be paying an amount of income tax and/or capital gains tax that is, at least, equal to 20 pence for each £1 of your total donation(s) to St John's and any other charities you support through Gift Aid.\* The tax already paid at source on bank interest and/or share dividends can count towards your income tax total.
2. If your circumstances change and you no longer pay sufficient income tax or capital gains tax, you should cancel this declaration.
3. You can cancel this declaration at any time for any reason by notifying the Stewardship Recorder. The declaration will then not apply to donations you make on or after the date of cancellation or such later date as you specify.
4. Please notify the Stewardship Recorder if you change your name or address while this declaration is still in force.
5. If you pay tax at the higher rate you can claim further tax relief in your Self Assessment tax return.
